Harleston Youth FC Terms and Conditions 2024-25 Season

The club considers the regular season to run for 8 months from September until April, broadly in line with the Norfolk & Suffolk Youth League and Norfolk Combined League programmes.

The subscription prices underneath cover one training session and one match per week during this period. Additional training sessions, friendly matches and tournaments may be arranged at each Team Manager's discretion outside of these dates and, if so, then an appropriate charge may be made for them.

Declaration: by completing online player registration via Spond, I confirm:

- I have parent/carer/guardian responsibility for this young person.
- I give consent for this young person to be registered with the relevant league / leagues to play for HYFC in matches for which they are age-qualified, and I understand that they cannot then be registered for any other club prior to June 30th 2025 without going through a formal transfer process.
- I will advise my team's manager of any changes to the contact details, health or any other circumstances around this young person of which the club should be aware for administrative or welfare purposes.
- I give permission for club coaches/volunteers to transport my child to and from club matches.
- I give permission for club coaches/volunteers to administer first aid in my absence, for example an ice pack, plasters or bandages.
- I give permission for photographs and video images of my child engaged in football activities to be used in club publications or displays, on the club web site or in the press solely to promote a positive image of young people in football.
- I acknowledge the need for my child to behave in a reasonable manner and I understand that any child deemed to behave in an unacceptable or consistently disruptive manner may be asked to leave the training session or match which they attend, and possibly also the club.
- I acknowledge that the club must be reimbursed for any FA fine incurred by my child or by myself.

Payment Options 2024-25 – all to be collected via Spond with 2.5% plus 20p per transaction payable by members on all transactions.

Option 1: Single payment of £80 by Sept 1st

Option 2: 2 payments of £45 by Sept 1st and December 1st

Option 3: 8 x monthly payments of £12 due on the 1st of each month from Sept-April – for those playing league games for the club

Option 4: 8 x monthly payments of £8 due on the 1st of each month from Sept-April for those training with the club but not playing league games (this replaces the £2 cash training-only option, as we look to go fully cashless as a club).

Any player for whom payment has not been received by 15 days beyond these dates will not be eligible to train or play any more matches until such a time as that payment is made.

That all said, it is a guiding principle of the club to support sport for all, and that no child should be denied the opportunity to play football with HYFC because of financial hardship. If this is the case, please in the first instance make your Team Manager aware and they will then work with the Club Treasurer to find an appropriate solution.
